# MINUTES OF THE REGULAR MEETING OF JANUARY 21, 2016

#### CALL TO ORDER – 1

Chair Heitkamp called the meeting to order at 11:03 a.m. at the Anoka City Hall.

#### ROLL CALL-2

Commissioners present were: Greg Lee, Anoka; John LeTourneau, Ramsey; Jim Dickinson, Andover; Eric Johnson, Champlin; and Bret Heitkamp, Champlin.

Commissioners absent and excused: Carl Anderson, Anoka; Kurt Ulrich, Ramsey; and Julie Trude, Andover.

Others present included Karen George, Executive Director; and Bob Vose, Commission Attorney.

#### APPROVAL OF AGENDA – 3

Motion was made by Dickinson and seconded by LeTourneau to approve the agenda as presented.

#### 5 ayes – 0 nays. Motion carried.

#### **ADMINISTRATIVE REPORTS – 4**

#### 4.1 Secretary

# 4.1.1. Approval of meeting minutes from December 17, 2015 work session

Commissioner Dickinson referenced page three, the sixth paragraph, where it states, "...bonded and unbonded..." He asked Ms. George to verify whether that should state "....grounded and ungrounded..." instead.

Motion was made by Dickinson and seconded by LeTourneau to approve the December 17, 2015 work session minutes as presented, with one possible change.

# 4.1.2. Approval of meeting minutes from December 17, 2015 regular meeting

Motion was made by Dickinson and seconded by LeTourneau to approve the December 17, 2015 regular meeting minutes as presented.

#### 4.2 Treasurer

#### 4.2.1. November Financial Reports

Commissioner Dickinson provided a brief overview of the November financial reports.

Motion was made by Johnson and seconded by Lee to accept the November Financial Reports.

#### 5 ayes – 0 nays. Motion carried

#### 4.3 Executive Director

Ms. George introduced existing employees that were recently promoted with the new organizational staffing changes. She stated that the subscriber survey was in the field and expected to present the results to the Commission in February. She stated that new policies have been implemented and staff is in the process of signing off on the updated Personnel Policy. She stated that staff is still researching the replacement of the cargo van. She stated that QCTV provided coverage of the special elections and also implemented a new show focused on millennials, titled The Grid. She stated that the I-Net failed again between the studio and the city of Anoka and noted that communications continue between the organization and Comcast regarding that system and the technical audit.

#### 4.4 Commission Organization

Ms. George stated that this is an off organizational year, as the bylaws call for these appointments on an election year, and therefore this information was

provided for informational purposes. She noted that the Commission could choose to make changes if desired.

It was the consensus of the Commission to leave the appointments as presented in the packet.

#### **GENERAL BUSINESS – 5**

#### 5.1 Designate Depository

Ms. George stated that this will be done on an annual basis to designate the depository.

Commissioner Dickinson referenced the acceptance of collateral and noted that typically that is done by a position on the staff rather than the Board because of the timeline needed and therefore suggested using the Executive Director.

Chair Heitkamp suggested including the Treasurer as well.

Motion was made by Heitkamp and seconded by Dickinson to designate US Bank as the official depository for 2016; that the PMA Financial Network, Inc. (Minnesota Municipal Money Market Fund) be designated as additional depository for 2016 for investment and cash management purposes only; and, that the Executive Director and/or Treasurer is hereby designated as the approval authority for the release and acceptance of all collateral to be held by the organization in conjunction with Commission funds on deposit with authorized institutions.

#### 5 ayes – 0 nays. Motion carried.

#### 5.2 Technical Audit Follow-Up

Ms. George stated that the previous month the technical audit was reviewed with Comcast at a work session meeting, with the direction from the Commission being to send a letter to Comcast with specific requests. She stated that she did receive a response from Comcast the previous day and an acknowledgement that Comcast representatives were unable to attend the meeting.

Mr. Vose stated that the letter is reflective that Comcast is willing to work with the organization on the subscriber issues and less willing to mention the I-Net issues. He stated that a couple of proposed solutions were provided in the letter regarding the I-Net. He noted that solutions were in line with what they anticipated and believed that those options could work. He referenced the substance of the I-Net verbiage used in the letter, "as a product of the organization going digital", that seems to suggest a problem. He noted that it

was Comcast that went completely digital and the organization is simply following suit. He suggested that the Commission table this item to allow additional time for review as the letter was just received the previous day.

Chair Heitkamp stated that the organization and Comcast have a long history of working together and stated that the letter acknowledges that.

Motion was made by Dickinson and seconded by LeTourneau to authorize staff to continue to work with Comcast on the technical audit review, outlining more specifics and timelines for the I-Net.

#### 5 ayes – 0 nays. Motion carried.

#### 5.3 Other

Ms. George played a short video that highlights some of the new programs.

#### Staff updates

Upon approval of the commission at the December meeting, there was an internal posting for three part-time associate producer positions. The following employees were promoted from part-time production assistant and they started on February 1:

- Winter Kucharski
- Alex Nolley
- Nick Quinn

Please join me in congratulating them on their new roles here at QCTV.

#### 2016 Kick-Off staff meeting

The QCTV staff meeting for review of 2015 and strategic planning for 2016 was held on January 6. Each staff member made a presentation about the favorite story they worked on in 2015 and why, one thing they learned this past year, and what project they are most looking forward to in 2016. Policy updates were presented for the Personnel Policy and the Public Purpose Policy. Staff changes were reviewed including: organizational chart, job changes, update on associate producer; and, overview of job duties with Lisa Monserud and Jim Reynolds. The management team provided an overview of the strategic plan and a look ahead for production and technology. Strategic planning staff input on the following areas: HD launch, EPG launch, Web site integration, Social media content, Razuna content, Customer service surveys, Marketing.

#### Subscriber survey update

The subscriber survey results have been tabulated and will be presented to the commission in a work session to be scheduled in March. Peter Leatherman of the Morris Leatherman Company will make the presentation and answer questions.

#### Replacement of cargo van

Staff has secured the paperwork for participating in the state contract. Estimated completion is April 1, 2016. The agenda includes a staff report requesting capital funds for the custom safety improvements and graphics wrap.

#### Technical audit update

Staff and legal counsel have met with Comcast staff to outline solutions for I-Net. Comcast is researching alternative signal transmission solutions and associated costs. This item continues to be worked on at the staff level and will return to the commission in March for further review.

#### HD channel transition begins

Channel 15 is slated to be the first QCTV channel to be transmitted in High Definition. Staff has initiated the HD channel request. Comcast has been responsive in providing information to prepare for the implementation. Staff is determining the timeline for implementation and launch.

#### **QCTV signal transmission to Comcast head-end**

Comcast has also been responsive to QCTV requests for signal transmission quality improvement unrelated to the Technical Audit and HD Channel Transition. Comcast technicians have indicated that the company will install equipment required to send/receive an SSI signal. This will dramatically improve the picture quality of programming seen by Comcast subscribers.

#### Web site implementation issues

The web site basic features are functioning. Staff presented a punch list to the vendor of outstanding items to be resolved. The priorities of the punch list affect our core services to cities. The number one priority is that the vendor has not delivered on backend coding to populate the video lists from our CableCast Pro playback system to the video lists on the web site. This specific problem affected our News & Views city segments and resulted in the December city segments being unavailable online and therefore not linked to city web sites for resident viewing. Staff continues to work with the vendor for resolution.

#### **CenturyLink negotiations**

CenturyLink representative have submitted a draft response to an earlier proposal. Negotiations continuing in late February.

#### Healthcare HSA Vendor change

The vendor managing the employee HSA accounts, Bancorp, has transfer management to a new company, HealthEquity for account services. Worked with new vendor and City of Andover to set up contributions and reports.

#### Monthly reports

Attached to this agenda item are the operations and technology updates. The January statistical reports are attached. Please note that the web site vendor

activated Google Analytics on January 6 so the date presented if from that date forward.

#### Subject: Operations Update

A considerable amount of time was spent planning QCTV's programming for 2016. I held individual meetings with all production staff to ensure goals and objectives are spelled out and will be met. Assignments were discussed and we planned our year of local programming. We had a meeting with the Anoka Historical Society Executive Director to plan out our shows for the year. I met with representatives from The League of Women Voters (Anoka, Blaine, and Coon Rapids) to plan our election coverage for the year. We decided to do two studio shows. "Caucus: Power Up Your Vote" will be produced at QCTV On February 10<sup>th</sup> hosted by Minnesota's League of Women Voters Executive Director Susan Sheridan Tucker and DFL spokesperson Vicki Wright and Republican spokesperson Kathy Tinglestadt. The purpose of the show will be to explain the caucus process and get people to go to caucuses. We will produce a second show in June called "Election Day Preparation". We will also produce the candidate forums for the various local races this fall.

I was a guest speaker at the Anoka-Hennepin STEP program's media class. In talking about a project with the students and QCTV, Instructor Steven Yeager and I came up with a program where the students could do their final project in our studio creating a show for QCTV. This would be a nice collaboration and would go towards our goal of producing more youth oriented programming. I also gave a talk on community programming to Cub Scout Pack 609 and they toured our production truck and did a QCTV promo that we played back at half time of an Andover hockey game.

In working with the LWC-ABC we produced a program on Campaign Finance Reform with guests Gary Goldsmith, Jerry Newton, and Kathy Tinglestadt.

The Anoka County Master Gardeners partnership continues and we produced a show called "In the Garden: Start from Seeds".

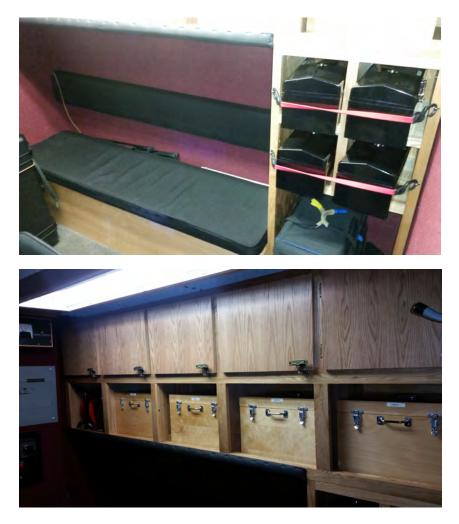
January programming resulted in several mobile van productions including several high school sports games. Champlin resident Steve Thomson from WCCO radio has been added to our roster of play-by-play and color commentators and he does a nice job. Cabinets were added to the mobile production van for storage of viewfinders and miscellaneous items. (Photos are enclosed.)

We also produced a new episode of "In the Game" which features interviews with coaches and athletes. We also produced a half time show that features clips of all of our QCTV programs called "What's New at the Q."

### Web Statistics – New Format

The new statistics report is taken from Google Analytics. The terms used are defined below.

Please note: The new format does show how many visitors went directly to the various city pages, but does not show the number of hits when the visitor started on a different page – i.e. the home page. Therefore the number of recorded visits is lower than was indicated on the old report. Google Analytics is much more accurate in reporting actual web traffic than what we were using previously.

**Page**: The pages visited, listed by URI. The URI is the portion of a page's URL following the domain name; for example, the URI portion of www.example.com/contact.html is/contact.html.

**Pageviews** is the total number of pages viewed. Repeated views of a single page are counted.

**Unique Pageviews** is the number of sessions during which the specified page was viewed at least once. A unique pageview is counted for each page URL + page Title combination.

The average amount of time users spent viewing a specified page or screen, or set of pages or screens

**Entrances** is the number of times visitors entered your site through a specified page or set of pages.

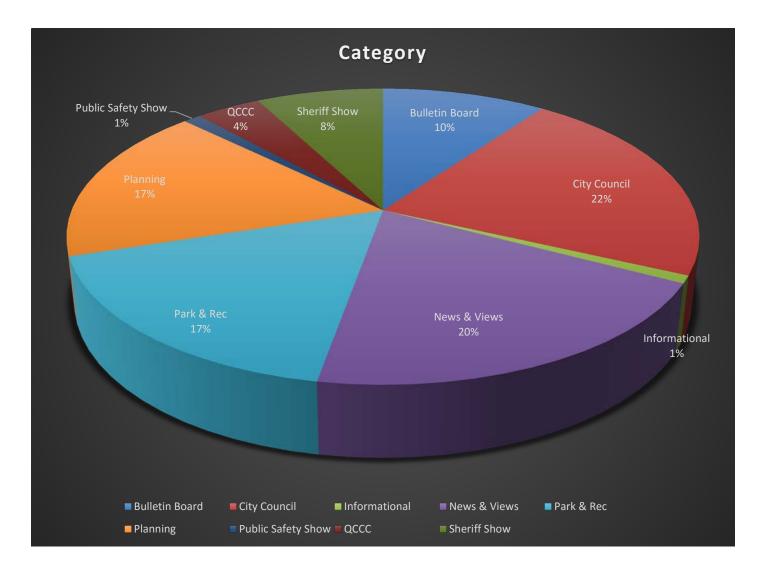
**Bounce Rate** is the percentage of single-page visits (i.e. visits in which the person left your site from the entrance page without interacting with the page)

# 5.1 Cargo Van Replacement

Subject: Cargo Van Replacement

On November 19th, 2015, the Cable Commission approved the purchase of a replacement cargo van utilizing the "Cooperative Purchasing Venture" with a not to exceed amount of \$30,000.00 before taxes. QCTV was approved to join the "Cooperative Purchasing Venture" by the State of Minnesota and was directed to work with Nelson Auto Center in Fergus Falls. Staff selected the Ford Transit, as this vehicle provided the necessary cargo space needed to transport scaffolding and other production gear. The final cost for this vehicle is \$23,165.61 before taxes and licensing fees. Delivery of the vehicle is included. The trade-in value for the old cargo van is not reflected in the pricing. Please see the attached quote from Nelson Auto Center for more details on the Ford Transit's pricing. Staff will proceed with finalizing this purchase.

### Safety Add-on's:

After the van is delivered, the current cargo van's rooftop platform should be retrofitted with safety improvements for use on the new van. Included in the retrofitting would be the addition of collapsible safety railings and a new custom safety ladder in order to gain access to the roof of the van. This platform is used extensively during the spring and summer months for our baseball and softball seasons in order for our cameras to see over the tall outfield and baseline fences. These safety add-ons would create a safer working environment for staff during these games. The price for the improvements are quoted for \$5,808.00 before tax.

#### **Graphics Wrap:**

Staff would like to include a graphics wrap onto the new cargo van, much like we currently have on our production truck and current cargo van. There are two choices for the addition of a graphics wrap:

Complete Wrap (wrapping the entire body of the vehicle): \$3,050.00 before tax (Estimated)



Partial Wrap (logo placement on only the sides of the vehicle, hood, and back door): \$900.00 before tax (Estimated)
